Mr. Henry Chih-Shang Kao, Chairman of CIECA hosted a luncheon for Joanne Ou, the new Representative of Taiwan Economic and Cultural Office in New Zealand on January 7, 2023.

The VIP guests included Mr. Chen Chao-Yih, Chairman of Taiwan-New Zealand Business Council; Secretary General Frank Wu and Director Hedy Lee from CIECA; Mr. Jason Lin, National Policy Advisors to the President; Mr. Jerry Guo, President of Taiwanese Chambers of Commerce in Oceania (TCCO); President Kao Shing-Hwang and Director Chiu Chang-Hsin, of China Airlines; Mr. James Chiao, CEO, Smart Cities Consulting Technology Inc.; etc.

Representative Joanne Ou used to be the spokesperson of the Ministry of Foreign Affairs and was appointed as the representative to New Zealand in December last year. She pledged to further promote the relations between Taiwan and New Zealand in the hope of achieving the goal of joining the CPTPP. The year of the 2022 also marked the 10th anniversary of the signing of the "Agreement between New Zealand and the Separate Customs Territory of Taiwan, Penghu, Kinmen, and Matsu on Economic Cooperation, ANZTEC." She looked forward to seeing more interaction and bilateral cooperation between the two countries in the future.

CIECA Visited the Italian Economic and Trade Office to Discuss the 7th Meeting of Taiwan-Italy Joint Business Council

Mr. Frank Wu, Secretary General of CIECA led colleagues from the European Department to visit with Mr. Davide Giglio, Representative of the Italian Economic, Trade and Cultural Promotion Office in Taipei on the afternoon of January 5, 2023. The two sides exchanged views on Taiwan-Italy bilateral cooperation opportunities in electric vehicles, biomedical and semiconductor industries. They also discussed the plan for the 7th Meeting of Taiwan-Italy Joint Business Council.

Representative Davide Giglio pointed out that Italy is a major manufacturer of motor vehicles in the EU, and currently intends to actively develop electric vehicle's charging systems whose key components are all relevant to information and communication industries, over which Taiwan has the edge. The two sides can benefit each other from exchanging experiences and combining their individual also resources. Italv wants to strengthen its chip capacity and facilitate knowledge exchanges with Taiwan. It is suggested that exchanges be made on semiconductor design and raw materials.

<u>CIECA Attended the Party for</u> <u>Celebrating the Republic Day of</u> <u>India</u>

At the invitation of the Indian Taipei Association, Secretary General Frank Wu attended the Party for Celebrating the Republic Day of India held at the Grand Hyatt Taipei on January 17, 2023. Mr. Gourangalal Das, Director General of India Taipei Association and Dr. Jaushieh Joseph Wu, Foreign Minister of the Republic of China (Taiwan) came to the stage to deliver opening speeches.

Director General Gourangalal Das stated that India is the fifth largest economy in the world and holds the current G20 Presidency. India will continue to cooperate with Taiwan and thanked Taiwan for giving concern and hospitality towards Indians living here.

Minister Wu stated that Taiwan-India relations had continued to flourish in recent years, the bilateral trade hit a record high of US\$8.4 billion in 2021, and memoranda of understanding were signed on GreenTech and Electronics. He pledged to continue to deepen bilateral cooperation between the two countries and promote a closer Taiwan-India partnership.

Experience Sharing on "Taiwan Economic Cooperation Mission to Côte d'Ivoire"

The Latin American and African Department of CIECA made a presentation on "Taiwan Economic Cooperation Mission to Côte d'Ivoire" on the CIECA monthly meeting of January 10, 2023. CIECA organized the Study Group to visit Côte d'Ivoire from November 7 to 13, 2022. In the monthly meeting, Ms. Muse Wu, a delegate of the group and a staff member of CIECA, shared the basic information, country profile, itinerary, visiting experiences, and suggestions with colleagues. Mr. Jeff Sun, Vice Chairman of CIECA, served as the Chief Delegate. A total of 16 delegates came from the industries of construction, packaging machinery, auto parts, food processing, logistics, and electro-mechanics, as well as from the public sector, and the education and training institutions on science and technology. The delegation went there for seeking cooperation opportunities.

Indeed the delegation made a lot of achievements. For example, EZ4U Enterprise Co., Ltd. negotiated the projects on social housing, commercial housing construction, the export of building materials production machinery, and other businesses with manufacturers in Côte d'Ivoire; Other than that, the purpose of joining the delegation by the K&H MFG. Co., Ltd., was to conduct an integrated evaluation of university system and its courses for appropriate planning, and to help build affiliation between colleges in Taiwan and Côte d'Ivoire with the aim of reaching the goals of fostering and exchanging talents for the two countries. In addition, Protrade Applied Materials Corp. reached a purchase agreement with GIE GPEC-CI in Côte d'Ivoire. Further more, Hong Sheng Packaging & Technology Enterprise Co., Ltd. intended to export automatic packaging equipment to Côte d'Ivoire and hoped to do trade business as well as personnel training and cooperation for advancing economic and trade relations between the two countries.
