Monthly Event Summary

CIECA Attended the 13th World Chambers Congress (WCC) Organized by the International Chamber of Commerce (ICC)

Mr. Chang Hong-Chia, Vice Chairman of CIECA; Mr. Steven Pan, Chairman of Silks Hotels Group & Executive Board Director of CNAIC; Mr. James S. Chu, Secretary General of CNAIC; and Mr. Chien Chan-Ying, Chief Investment Officer of Taishin Financial Holdings Co., Ltd. went to Geneva, Switzerland to attend the 13th World Chambers Congress organized by the International Chamber of Commerce (ICC) from June 21 to 23, 2023. The theme of the conference is "Peace and Prosperity through Multilateralism."

The first day's lecture focused on multilateralism, and how businessmen in the 21st century can create peace and prosperity through international

trade. At the same time, Mr. Taras Kachka, Deputy Minister of Economy, Ukraine, was invited to deliver a speech on "Building a Peaceful Future for Ukraine: Economic Recovery and Multilateral Support."

The topic of the second day focused on innovation; discussions were held in multiple sub-venues. Attendees were free to participate in topics of their interest, including the development of chambers of commerce, digital trade and digital transformation, certificate of origin, and dispute resolution services, etc. The topic of the third day's lecture focused on sustainable development, understanding the responsibility of the supply chain, and business guidelines for energy transition.

In addition, CIECA took the opportunity of attending this conference, where many national chambers of commerce gathered, to meet with Ms. Maria Fernanda Garza, Chair of the International Chamber of Commerce, ICC; Mr. John WH Denton AO, Secretary General of the ICC; Mr. Nicolás Uribe, Chair of World Chambers Federation (WCF); and Ms. Rosa Bueno, President of the Lima Chamber of Commerce. The Joint Conference of ROC-Korea and Korea-Taiwan Business Councils Promotes Economic and Trade Exchanges and Cooperation Between the Two Countries

"The 47th Joint Conference ROC-Korea and Korea-Taiwan Business Councils" co-hosted by CIECA and the Federation of Korean Industries (FKI) was successfully held at Shangri-La Far Eastern in Taipei on the morning of June 1, 2023. The conference was co-chaired by Mr. Jimmy Chu, Chairman, ROC-Korea Business Council, CIECA and Dr. Joon Kim, Chairman of Korea-Taiwan Business Council, FKI. During the conference, Mr. Liang Kuang-Chung, Representative of Taipei Mission in Korea; Mr. Lee Eun-Ho, Representative of Korean Mission in Taipei; and

Dr. Lee Guann-Jyh, Deputy Director General of Bureau of Foreign Trade, MOEA were invited to deliver remarks respectively. They were expressing the support from the governments of the two countries for the non-governmental economic cooperation between Taiwan and Korea.

More than 135 guests were present at the conference from Taiwan and Korea, including representatives from enterprises, governments, and academia. Sixteen Korean students from JeJu National University, Ajou University, and Konkuk University also participated in the conference.

There are four topics discussed in the plenary session. The papers of the first topic of "Economic trends and outlook of Korea and Taiwan" were presented by Dr. Shu-Fei Yang, Associate Research Fellow/Deputy Director of the Regional Development Study Center, Chung-Hua Institution for Economic Research and Ms. Kui Ock Kim, Director of Investment Attraction Division, Busan Metropolitan City. The papers of the second topic of "Manufacturing & Service Cooperation" were presented by Mr. Miro Lin, CEO, Machine Tool Business

Group (Taichung), of the Fair Friend Group, Dr. Dae-Geun Lim, Chairman, Korean Academic Association Global Cultural Contents, and Mr. Dae-Hyun Kim, CEO of the Korean Toss Lab, Inc. The papers of the third topic of "Green Energy & Strategic Materials Cooperation" were presented by Dr. Lin Jo-Chen, CEO, Taiwan Hydrogen and Fuel Cell Partnership; Mr. Sam Hwang, Executive Vice President, SK Oceanplant; and Mr. Soo-Hong Chae, Director, Trade and Security Research Center, Korean Security Agency of Trade and Industry (KOSTI). The papers of the forth topic of "Information and Technology Cooperation" were presented by Mr. Terry Tsao, SEMI's Global Chief Marketing Officer and President of Taiwan region and Dr. Eun-kyo Cho, Research Fellow, Korea Institute for **Industrial Economics** & Trade (KIET).

The Korean delegation to attend "The 47th Joint Conference of ROC-Korea and Korea-Taiwan Business Councils" was the first delegation led by FKI coming to Taiwan after the pandemic of Covid 19. The conference provided an important communication

platform for the governments and business representatives of Taiwan and Korea to acquire in-depth understanding of the two countries' Economic trends, and the prospects for industrial cooperation and development. The participants also conducted discussions on related topics. Through this conference, enterprises and institutions from the two countries have established a closer cooperative relationship, promoted technical exchanges and resources sharing, and achieved win-win results.

2023 Taiwan Economic and Trade Delegation to Poland and Hungary

To assist Taiwan businessmen in seeking commercial opportunities in the European market, CIECA organized the "2023 Taiwan Economic and Trade Delegation to Poland and Hungary" visiting the two countries from June 17 to 26, 2023. The Honorary Advisor to the Delegation was Mr. Chen Chern-Chyi, Deputy Minister of Economic Affairs, MOEA; and the Chief Delegate was Mr. Robert Ou Young, Vice Chairman of CIECA and Chairman of ANKO Food Machine Co., Ltd. A total of 23 representatives from government, public associations and enterprises joined this delegation.

While the delegation visited Poland, the "19th Poland-Taiwan Joint Business Council Meeting" was held in Warsaw on June 20. The Meeting was co-chaired by Vice Chairman Robert Ouyang and Mr. Andrzej Szumowski, Vice President, Polish Chamber of Commerce. Mr. Grzegorz Piechowiak, Secretary of State, Polish Ministry of Economic Development and Technology and Mr. Chen Chern-Chyi, ROC Deputy Minister of Economic Affairs, were invited to deliver

speeches respectively. During the meeting, Experts from Taiwan and Poland made reports and exchanged views on the topics of "Smart City," "E-mobility," and "Hydrogen Energy." After the meeting, one-on-one business matching meetings were arranged to facilitate finding business opportunities.

ROC's Ambassador Gu Wenjian to the Republic of Haiti Visited with Chairman Henry Chih-Shang Kao of CIECA

On June 7, 2023, Ambassador Ku Wen-Jiann of the Republic of China (Taiwan) to Haiti, visited with Chairman of CIECA, Mr. Henry Chih-Shang Kao. Ambassador Ku said that after the assassination of Haitian President in July 2021. The primary goal of the current transitional government is to hold the next

election. Nevertheless, the government can hardly control the turbulent gangs, coupled with the raging coronavirus and cholera, making it impossible to hold elections even after its term has expired. It seems that only international intervention can quell the chaos.

Regarding the cooperative relationship between Taiwan and Haiti, Chairman Kao said "At the current stage, we can first help Haiti integrate their most needed projects and then send their personnel to Taiwan to learn related technologies. After returning to Haiti in the future, they will be able to independently operate production and to repair equipments when necessary. Haiti is rich in tropical crops such as sugar and bananas, but lacks agricultural processing technology. If crops can be processed into commodities with higher added value and then exported to foreign countries, the economic benefits will be much higher.

The two gentlemen had a pleasant talk, exchanged gifts after the meeting, and both hoped that the CIECA and the

ROC embassy in Haiti could cooperate further in the future to consolidate the friendship between the two countries.
