Monthly Event Summary

"Taiwan & EU Business Networking Reception" Combined With
"2023 European Innovation Week"
to Deepen EU-Taiwan Cooperation
Among Industries, Governments,
Academia and Research Institutes

CIECA and the European Chamber of Commerce Taiwan (ECCT) co-organized the "Taiwan & EU Business Networking Reception" at Regent Taipei on May 30, 2023. CIECA Chairman Henry Kao and Chairman ECCT Giuseppe Izzo served as the co-host. Ms. Wang Mei-Hua, Ministry of Economic Affairs; Ms. Maive Rute, Deputy Director-General of DG GROW, European Commission; and Mr. Filip Grzegorzewski, Head of Office of European Economic and Trade Office (EETO) in Taipei; were invited to deliver opening remarks respectively.

Combining with the "2023 European Innovation Week," the event was held for welcoming the delegation of the DG GROW from European Commission to visit Taiwan. On that occasion, the distinguished speakers from Taiwan and Europe all mentioned that Taiwan and the EU share common values of democracy, human rights, and laws and order. Looking ahead, Taiwan and the EU have big room for cooperation among industries, government, academia in the fields of energy (including circular green economy, renewable energy, and electric vehicles), digitalization (chips, information security), and supply chain resilience. Beyond that, cultural and academic exchanges could also be furthered through sponsoring concerts and many other cultural activities. It is expected that more opportunities for cooperation among government, enterprises and the public will be created.

Representatives of various industry associations in Taiwan, European countries' representatives in Taiwan, European delegations, heavyweight Taiwanese companies investing in the EU, listed companies, and important European businessmen in Taiwan were invited to attend the said event. More than 200 guests were present at the reception, including representatives from the offices of European Union and its member states in Taiwan.

CACCI President Visited Taiwan from May 17 to 18

The delegation of the Confederation of Asia-Pacific Chambers of Commerce and Industry (CACCI) visited Taiwan from May 17 to 18. This has been the first time for Mr. Peter McMullin AM, President of CACCI to lead a delegation to visit abroad since he was elected last year. The delegation consisted of 19 people from Australia, Iran, Pakistan, Georgia, Hong Kong, South Korea, Taiwan, and the Philippines. On May 17, the delegation called on Mr. Chen Chern-Chyi, Deputy Minister of Affairs; Economic Mr. Kung Ming-Hsin, Minister of National Development Council; Mr. Tien Chung-Kwang, Deputy Ministry of

Foreign Affairs; and Mr. Thomas T. L. Wu, Chairman of Chinese National Association of Industry and Commerce (CNAIC). On May 18, Chairman Henry Chih-Shang Kao accompanied President Peter McMullin AM to meet with President Tsai Ing-Wen of the Republic of China, while the visiting group called on MiTAC Information Technology Corp. and Delta Electronics Industry Co., Ltd. 2023 Saint Lucia Trade & Investment Promotion Seminar Held on May 24, 2023

The Ministry of Foreign Affairs and CIECA, the two co-organizer, held the "2023 Saint Lucia Trade & Investment Promotion Seminar" on May 24 from 9 a.m. to 12 noon at Shangri-La Far Eastern Taipei. The purpose of the seminar is to strengthen the bilateral economic, investment and industrial exchanges between Taiwan and Saint Lucia, and to familiarize Taiwanese entrepreneurs, investors and government officials with the business environment in Saint Lucia. More than 70 guests and nearly 50 manufacturers attended the seminar. The two sides enjoyed a pleasant exchange of views, having laid a solid foundation for the bilateral political and economic relations in the future.

During the seminar, Ms. Lien Yu-Ping, Director General of Department of International Cooperation and Economic Affairs, MOFA; H.E. Ambassador Robert Kennedy Lewis of Saint Lucia to Republic of China (Taiwan); and Mr. Mike Hung, Vice Chairman of CIECA; were invited to deliver remarks respectively. The Hon. Dr. Ernest Hilaire, Saint Lusia's Deputy Prime Minister & Minister for Tourism, Investment, Creative Industries, Cultural and Information and his team members--Mr. Sidney Darwin Guard. Chairman of Cultural Development Foundation; Ms. Alana Lansiquot, Senior Investment Manager, Invest Saint Lucia; and Ms. Tajam Brown, Officer, CIP--made Marketing presentations to introduce the investment environment and advantages, beautiful natural wonders, tourism and cultural industries of the Saint Lucia. Through these presentations, they tried to attract Taiwanese businessmen to make investment out there to create a win-win situation.

CIECA Chairman Henry Kao Held a Farewell Luncheon for Dr. Tung Chen-Yuan, the Newly-Appointed ROC Representative to Singapore on May 4, 2023

On behalf of CIECA, Chairman Henry Kao held at Shanghai Pavilion of the Shangri-La's Far Eastern Plaza Hotel on May 4 a farewell luncheon in honor of Dr. Tung Chen-Yuan who was appointed as the ROC's new Representative to Singapore.

Representative Tung was ROC's ex-Minister of Overseas Community Affairs Council, R.O.C.; former Representative of Taipei Economic and Cultural Office in Thailand; former Advisory Board Member of National Security Council; former and Spokesperson for Executive Yuan. He was also a scholar of international political economy and taught at National Taiwan University and **National** Chengchi University. Representative Tung who became the ROC's new Representative to Singapore as of May 8.

Chairman Kao said that "Taiwan and Singapore are very important investment and trade partners for each other, and they are geographically convenient located." Representative Tung proposed that the two countries should strengthen cooperation on semiconductors, smart agriculture, and biotechnology. During the luncheon, the two sides exchanged views on the investment situation of Singapore and Taiwan in recent years, the important bilateral cooperative indus-

tries and the handling of joint economic meetings.

CIECA Chairman Henry Chih-Shang Kao hosted a luncheon at the Regent Hotel for Mr. Jason Lin. National Policy Advisor to the President of the Republic of China; Mr. Richard Lee, President of Taiwanese Business Association of New Zealand; Mr. Jerry Guo, President of Taiwanese Chamber of Commerce in Oceania; and Ms. Hedy Lee, Director of Asia Pacific Department, CIECA to discuss business opportunities in Australia and New Zealand and the planning of the 2023 Joint Conference of the Taiwan-New Zealand & New Zealand-Taiwan Business Councils on May 19, 2023.

The year of 2023 coincides with the 10th anniversary of the signing of the "Agreement between New Zealand and the Separate Customs Territory of Taiwan, Penghu, Kinmen, and Matsu on Economic Cooperation (ANZTEC)." Mr. Richard Lee, Presi-

dent of Taiwanese Business Association of New Zealand said that "Taiwanese Business Association of New Zeland will organize a delegation to visit Taiwan in this September. In addition to participating in the economic joint meeting organized by CIECA and the New Zealand-Taiwan Business Council (NZTBC), it is also planned to hold a "New Zealand Week" in Taiwan to promote New Zealand food and agricultural produce."

Chairman Kao also concurred that "many business opportunities, especially for fresh milk and dairy products in food industry are lying ahead for Taiwan and New Zealand." Ever since the bilateral meeting between CIECA and the New Zealand-Taiwan Economic Association held in Wellington, New Zealand in 2019, it has been suspended due to the pandemic of Covid 19. It is hoped that after the full opening up of national borders this year, the Taiwan-New Zealand bilateral economic joint meeting will be ressumed for giving the two countries' businessmen opportunities to have real exchanges and promote New Zealand manufacturers to invest in Taiwan more.

Regarding the theme of the future Taiwan-Denmark Economic Cooperation Conference, Director Peter Sand and Director Jeppe Solmer mentioned four topics that could be discussed: (1) Food Industry: promoting low-carbon agriculture and Taiwan-Denmark bilateral food certification, (2) Smart Medical: creating digital medical system, (3) Quantum Technology: applying it to semiconductors and chips, (4) Green Energy: using long-term cooperative relationship.
