#### Monthly Event Summary

# The Department of International Cooperation and Economic Affairs, MOFA, R.O.C. (Taiwan) Met with Diplomats from Latin America

On April 11, 2022, The Department of International Cooperation and Economic Affairs, MOFA, R.O.C. (Taiwan) met with Ambassadors from Belize, Guatemala, Honduras, and Paraguay's Commercial Attaché at the International Conference Room of the Diplomatic Quarter. The MOFA also invited Chinese International Economic Cooperation Association (CIECA), Taiwan, the Importers and Exporters Association of Taipei (IEAT) and Taiwan External Trade Development Council (TAITRA) to participate in the meeting to discuss 2022 Economic Cooperation Programs between Taiwan and its diplomatic allies from Latin America. Director General Y. C. Tsai of the Department of International Cooperation and Economic Affairs,

MOFA, R.O.C. (Taiwan) delivered an opening remark. H.E. Ambassador Candice Augusta Pitts of Belize, H.E. Ambassador Willy Alberto Gómez Tirado of the Republic of Guatemala, H.E. Ambassador Eny Yamileth Bautista Guevara of the Republic of Honduras, and Ms. Macarena Barboza, Commercial Attaché, Embassy of the Republic of Paraguay to the R.O.C. attended the meeting and exchanged views with participating associations.

The Ministry of Foreign Affairs stated in a briefing that many activities have been planned for this year, such as holding trade exhibitions and bilateral Joint Business Council Meetings, organizing missions for investment opportunities, and business matchmaking events. It is hoped that through above activities, the economic ties between Taiwan and its diplomatic allies will be enhanced, and a mutually beneficial partnership strengthened in the post-pandemic era.

#### <u>New Director of NZCIO Mark</u> <u>Pearson Visited Chairman of</u> <u>CIECA, Mr. Kao, Chih-Shang</u>

On the afternoon of April 13, 2022, Director Mark Pearson of the New Zealand Commerce and Industry Office (NZCIO), and Ms. Alexandra Reuhman, the Section Head of Economic Affairs of NZCIO visited Mr. Kao, Chih-Shang, Chairman of CIE-CA. The two sides exchanged views on Taiwan-New Zealand trade situation, the non-governmental Joint Business Conference and the CPTPP.

Since the signing of the Agreement between New Zealand and the Separate Customs Territory of Taiwan, Penghu, Kinmen, and Matsu on Economic Cooperation (ANZTEC) in 2013, bilateral trade has continued to grow even though the pandemic has hit global economy hard. Chairman Kao suggested that the two countries find key fields of industrial cooperation to increase profitability. Taking food industry cooperation as an example, a local factory transforming raw materials into processed foods and then exporting them could not only prolong the shelf life of goods, but also earn more profit than directly

exporting raw materials. This is also more in line with people's needs for a quick meal in modern time. In the future, even food recipes can be exported to Hong Kong, Singapore, and Malaysia, because people over these places have similar food tastes in Taiwan. The market will thus no longer be confined to two countries.

Director Mark Pearson agreed with Chairman Kao on that aspect. He mentioned that New Zealand will focus on developing high value-added industries such as new information and communication technology and renewable energy technology. New Zealand also has an edge over the technologies on geothermal and wind energy which could be the areas for more cooperation with Taiwan. At present, New Zealand is committed to prioritizing the restoration of education market and tourism industry after the epidemic in the hope of attracting more Taiwanese to study and travel in New Zealand.

The two sides also talked about the planning of holding the Taiwan-New Zealand Joint Business Conference this year. Chairman Kao said that it has been suspended in the past two years due to the epidemic; New Zealand has already opened its borders this year. He wished to hold the Conference in Taipei and a New Zealand delegation could come to attend it. Director Pearson responded that the New Zealand-Taiwan Business Council (NZTBC) hoped to promote the Joint Business Conference too, but the prerequisite for holding a physical meeting in Taipei would be the cancellation of Taiwan's quarantine measures for entry in containing COVID 19 to facilitate New Zealand to recruit members for her delegation.

In addition, regarding Taiwan to apply for joining the CPTPP, Chairman Kao said that most of the enterprises in Taiwan do not really understand the connotation of the agreement. Perhaps in the future, Director Pearson will be invited to explain the importance of CPTPP to Taiwanese businessmen and the benefits that Taiwan businesses can gain from CPTPP. Director Pearson acknowledged that after joining the CPTPP stricter norms may bring many more difficulties but reassured that multinational trade cooperation will be the trend in the future.
