Monthly Event Summary

<u>The 20th Taiwan-Germany Joint</u> <u>Business Council Meeting Held on</u> <u>August 25</u>

The Taiwan-Germany 20th Joint Business Council Meeting was held by CIECA, German Trade Office Taipei and Taiwan Committee of German Business on August 25, 2022. The Meeting was co-chaired by Mr. Jimmy Chu, Chairman of Fair Friend Group and Mr. Dirk Sänger, Managing Partner of C. Melchers GmbH & Company. Mr. Chen Chern-Chyi, Deputy Minister of Economic Affairs, R.O.C. and Dr. Franziska Brantner, German Parliamentary State Secretary at the Federal Ministry for Economic Affairs and Climate Action were invited to deliver opening remarks respectively. The VIPs in the Meeting included Dr. Shieh Jhy-Wey, Representative of Taipei Representation in the Federal Republic of Germany and

Dr. Jörg Polster, Director General of German Institute Taipei, etc.

A Panel Discussion was specially arranged for the Meeting. The moderators of the panel discussion were Mr. Alex Y.M. Peng, Executive President of Industrial Technology Research Institute (ITRI) and Mr. Axel Limberg, Chief Representative and Executive Director of German Trade Office Taipei. They guided the attendees from both Taiwan and Germany to share their experiences. The panelists from Taiwan side included Mr. Vincent Liu, CEO of LCY Chemical Corp., Dr. Sebastian Schöning, CEO of FFG Europe and Americas Group, and Mr. Jim Chen, General Manager of Kingsteel. The panelists from German side included Mr. Erdal Elver, President and CEO of Siemens Taiwan, Mr. Aditya Rankirshna, Vice President of Mr. Andreas Siemens Taiwan. Schmidt, Managing Director of Bosch Taiwan, and Mr. Kin Wah Chay,

Managing Director of BASF Taiwan, etc. The discussed issues contained the dilemma and challenges faced by enterprises in carbon reduction, and the impact of circular economy on carbon neutrality. Industry representatives were invited to exchange views in the panel discussion.

More than 110 corporate representatives attended the Meeting on-site and online, and the interactions between the two sides' aprticipants were very lively.

During the Meeting, a MOU was signed by Siemens Taiwan, Kingsteel, and Ruh-Yih Automation, in which they focused on future cooperation in the fields of enterprise digital transformation, virtual-real integration, energy saving, and the solutions of carbon reduction.

The Taiwanese representatives at the signing ceremony were Minister Pan Wen-Chung, Ministry of Education and Minister Kung Ming-Hsin, National Development Council, while the Australian representative was Representative Jenny Bloomfield, Australian Office in Taiwan. After the opening speeches, the above three representatives jointly completed the signing of the Action Plan.

Australia and Taiwan enjoy important partnership in education. There are more than 10,000 Taiwanese students leaving for Australia to study annually, and many Australian students come to Taiwan to study through the "New Colombo Plan" initiated by the Australian government. The "Australia-Taiwan English Language Learning Partnership Action Plan" contains Bilingual Teacher Training Program, Sister School Partnership, Joint Degree Program, Technical and Vocational Education Training, etc. It is anticipated that through this Action Plan, the educational exchanges and cooperation between Taiwan and Australia can further their educational partnership.
