The World this Month— Africa

• The Ministry of Economic Affairs has set up a "Ministry of Economy Affairs Project Office to Promote the African Market," on March 14, 2016. Chen-Chung Mr. John Deng, Minister of Economic Affairs. decided to set up a special office during the 10th WTO Ministerial "Africa Conference. when the Expanding Export Seminar" was held at Nairobi, Kenya.

The purpose of the office is to integrate all forces and strengthen our expansion into the African market, and the Taiwan External Trade Development Council will be responsible for implementation. The office will develop integrated plans for expanding the African market that will be published in the annual report on APP, and to coordinate the resources of public associations to expand their benefits.

- Three of Africa's major regional economic communities - the East African Community (EAC), the African Southern Development and (SADC) the Community Common Market for Eastern and Southern Africa (COMESA), signed the agreement of "Tripartite Free Trade Area" (TFTA) at Egypt in The main objective is June, 2015. to establish the three pillars of "market integration in Africa". "infrastructure" "industrial and development".
- Currently, few Taiwanese invest in Africa, while among Africa, India, and the Middle East there are long term historical factors that lead to closer economic and trade relationships. For Taiwan's business that are more familiar with the Middle East or India, entering the TFTA market through joint ventures may be easier.

• Regarding government assistance, in addition to financial assistance to countries with diplomatic relations, the government can also invite Taiwanese businesses with growth potential to invest in the African market via a systematic approach. Industry alliances can be formed to export products and services using investment to improve related industries and the export of products help Taiwan's business and to develop in the local market.

Europe

- To facilitate economic cooperation and trade between Switzerland and ROC. hold CIECA will Networking Dinner on the 3rd of March. The guests include Mr. Adolf Ogi, Former President of Switzerland, members of the Swiss economic and trade delegation, formal representatives of ROC and CEOs from related industries to communication expedite the enterprises, between and substantiate furthermore. to economic and trade cooperation between our two countries.
- The next meeting of the ICC Permanent Heads of National

Committees will take place on 14th and 15th of March at the offices of ICC Netherlands in the Hague. The meeting is regularly organized twice a year, focusing on the theme greater inclusion the of cooperative perspective on tglobal trade & investment to reach a consensus on the ICC's interior works and showcase pragmatic tools for trading in today's global marketplace. Director Christophe Lai of the Economic Division of the Taipei Representative Office in France will join the meeting as the representative of ICC Chinese Taipei.

• To help our enterprises expand into the European market, a trade and economic delegation will visit Turkey, Finland, and Russia from April 21 to April 30 this year. The delegation will focus on sectors including ICT, Consumer Electronics, Green Energy, Machinery, and Food. To highlight the importance of this delegation, the delegation will be led by a high-ranking government official of the Ministry of Economic Affairs.

- Brussels Invest and Export, BIE and Flanders Investment & Trade, FIT will jointly arrange a delegation to visit Taiwan between 25-26, April and also hold the Belgium- Taiwan Industry Cooperation Business Opportunity Forum in Taipei.
- The Industrial Development Bureau, the Committee for Precision Machinery Industry Development (both of the Ministry of Economic Affairs) and CIECA have jointly planned for the "2016 Taiwan-Germany Productivity/ Industry 4.0 Forum) to be held at Taipei on May 30th.
- For further cooperation and interaction between CIECA and the Confederation of British Industry(CBI), CIECA will invite the International Director of CBI. Mr. Moore, to visit Simon between May 30th to June 3rd. CIECA will also hold the 17th Joint Meeting of the Taiwan- Britain Business Council and arrange meetings Mr. between Moore and representatives of government and industry.

- Mr. Vusi Khumalo, President of the South African Chamber of Commerce & Industry, was invited to visit Taiwan by CIECA during March 21 to 25, 2016.
 - In order to boost Taiwan and South Africa's bilateral economic energy industry cooperation, Khumalo will take part in the "2016 Smart City Summit & Expo", hosted by the Taipei Computer Association. In addition, Mr. Khumalo will visit an Incubation Center. **LED** illumination and solar energy industry... etc.
- In order to strengthen trade and investment between Taiwan Latin America, the "2016 Taiwan Economic & Trade Delegation to Brazil and Paraguay" organized jointly by the Ministry of Economic Affairs and the CIECA will take place between 8th to 16th of April to investigate the investment environment. This delegation will organize trade symposiums, and arrange to meet local potential buyers to help the companies of our country explore business opportunities.
- Mr. Nuno Rodrigues, president of the

Business Association of São Tomé e Príncipe, a country friendly to us, will lead a business delegation to Taiwan from April 19 to 23, 2016, and hold the 3rd Taiwan- São Tomé e Príncipe Joint Business Councils Meeting.

Asia-Pacific/Oceania

- The ASEAN Economic Community was formally established at the end of 2015 and its future economic growth potential is enormous. CIECA and the Federation of Thai Industries will jointly conduct the Taiwan-Thailand 25th Economic Cooperation Conference. There will be in depth discussions on "green energy", "SME" and "smart manufacturing".
- CIECA is planning to organize a delegation to Mongolia on May 10-15, 2016 and participate in the "15th Joint Meeting between CIECA and MNCCI". The meeting will be Mr. co-chaired by Baatarjav Chairman LKHAGVAJAV, of MNCCI, and Mr. Peter W.J. Huang, Chairman of the Mongolian Committee of CIECA.
