
2016 ROC Business Delegation to Sri Lanka and India

The 14th Taiwan-Poland Joint Business Council Meeting

"The 14th Taiwan-Poland Joint Business Council Meeting" was held at Room 101 B at the Taipei International Convention Center on October 21. A delegation composed of 17 Polish government officials and business leaders was led by Mr. Tadeusz Koscinski, Undersecretary of State, Ministry of Economic Development, to attend the meeting.

The meeting was co-chaired by Mr. Fred Huang, Vice Chairman of CIECA, and Ambassador Jerzy Drożdż, Member of the Board, Director of Foreign Relation Department, Polish Chamber of Commerce. Mr. Yang, Wei-Fuu, Vice Minister, Ministry of Economic Affairs, and Mr. Tadeusz Koscinski, Undersecretary of State, Ministry of Economic Development, also addressed at the meeting.

Several major topics were discussed at the meeting, including "the Revitalizing Five Industries for Economy," "PARP Taiwan's delivering growth policy for SME Poland & sector in Creating opportunities for business cooperation," and "the Development of Smart Cities in Taiwan." In conjunction with the 22nd Ministerial Joint Economic Cooperation Meeting, the 23rd Joint Meeting of Chinese-Philippine & Philippine-Chinese Business Councils was held at the Shangri-La's Far Eastern Plaza Hotel, Taipei on October 28, 2016. Mr. George T. Barcelon, President of Philippine Chamber of Commerce and Industries (PCCI) and Mr. George Siy, Chairman of the Philippine-Chinese Business Council (PCBC), led a big delegation with 59 of Makati members CCI. Anvil Business Club. Chinese-Filipino Inc., Business Club Taiwan CCI-Philippines, Philippine Chamber of Commerce and Industries (PCCI)-Las Piñas City and PCCI-Parañaque City.
