# Representative of Manila Economic and Cultural Office Approves of President Tsai's New Southbound Policy

Mr. Ali Du, Advisor of CIECA, and Mr. Resident Angelito T. Banayo, Representative of the Manila Economic and Cultural Office met on March 17, 2017 and dined together. Mr. Banayo expressed his support and encouragement for President Tsai's New Southbound Policy and the current development of bilateral relations between Taiwan and the Philippines. mentioned that President Duterte intends to expand Taiwan's Southbound base in the 90's - the Subic Bay Freeport Zone - in order to attract more investment from Taiwan. Regarding the Agreement Concerning the Facilitation of Cooperation on Law Enforcement in Fisheries, he has confidence that it will be finalized in short order under the diligent work of Taiwan's Representative to the Philippines Gary Song-Huann Lin and his colleagues. Bilateral trade between the two countries increased from US\$9.7 billion in 2015 to US\$10.8 billion last year. Taiwan is the Philippines' 12th largest foreign investor.



# Representative of New Zealand Ms. Moira Turley Agreed to Assist in Restarting the Joint Conference of ROC-New Zealand & New Zealand-Taiwan Business Councils

Director Moira Turley of the New Zealand Commerce and Industry Office led a delegation of five to visit Chairman Henry Kao of CIECA on March 20<sup>th</sup>. During the meeting, Chairman Kao noted that the joint conference has been suspended since 2009. The absence of this stable platform for bilateral exchange is impeding the progressive cooperation and development of the business communities of our two nations.

Director Turley agreed to assist CIECA in finding a suitable chamber of commerce as a counterpart organization in order to restart the bilateral conference mechanism.

Director Turley affirmed that the New Zealand government considers the Taiwanese market to be very important. Chairman Kao recommended that New Zealand can establish a series of New Zealand Houses at Taipei, Taichung and Kaohsiung for the purpose of introducing New Zealand products to the Taiwanese people to promote closer commercial ties between the two sides. New Zealand produces a wealth of agricultural and fishery products such as fruits and lobsters and the emphasis on such products is freshness. Chairman Kao suggested that if direct flights between Taiwan and New Zealand is to be resumed, they can stop over at Sydney to stimulate business operations. Finally, Chairman Kao also advised that New Zealand businesses can utilize the expertise and experience of Taiwanese businesses in e-commerce to assist New Zealand enterprises in selling their products to Taiwan.

## Taiwan Economic and Trade Delegation to Bulgaria, Macedonia and Kosovo

In order to help our enterprises promote the Balkan market, CIECA and the New Taipei City Small and Medium Enterprise **Directors** Honorary Association will co-organize the delegation to Bulgaria, Macedonia and Kosovo on April 15-24 of this year. The delegation, led by Mr. Fred Huang, Vice Chairman of CIECA, will focus on sectors of ICT, food/agriculture, biotechnology, green energy, machinery and hardware processing.

The delegation will visit Bulgaria on April 16-20 and attend the 5th Joint Business Forum Sofia-Taipei on April 19. The meeting will be co-chaired by Mr. Tsvetan Simeonov, President of Bulgarian Chamber of Commerce and Industry; and Mr. Fred Huang, Vice Chairman of CIECA. Several topics will be discussed at the meeting, including economic and investment environment on Bulgarian and Taiwan, and experiences sharing on Bulgaria.

The delegation proposes to visit the Economic Chamber of Macedonia and has networking with the Chamber's members on April 20.
