Chairman Henry Kao Attended Ministry of Foreign Affairs Luncheon in Honor of Australian Parliamentary Delegation

Chairman Henry Kao attended luncheon held by the Ministry of Foreign Affairs on May 4th in honor of an Australian parliamentary delegation consisting of the Hon. Kevin James Andrews MP, Senator David Christopher Bushby, Hon. Stuart Rowland Robert MP, Senator Dean Anthony Smith, Senator James William Paterson and Mr. Kevin John Hogan MP. The two sides exchanged their views of economic and social development issues in our two nations and established a good of channel communications. The Australian parliamentary delegation also visited President Tsai, Ing-wen on the same day. Hon. Andrew MP and Sen. Paterson both expressed their desire for the two sides to develop closer relations.

The 16th Joint Meeting between CIECA and MNCCI

The Chinese International Economic Cooperation Association (CIECA) and the

Mongolian National Chamber of Commerce Industry and (MNCCI) signed memorandum of understanding in 2002. Since then, the two organizations alternately held the "Joint Meeting between CIECA and MNCCI" at Taipei and Ulaanbaatar without interruption. This year, CIECA held the meeting at Taipei and Mrs. Magvan Oyunchimeg, CEO of MNCCI, led a delegation of agricultural food products, beverages, construction, mining, IT and tourism business representatives and contractors began to arrive on May 14th.

Deputy Minister of Foreign Affairs François Wu. Chih-Chung delivered remarks at the welcoming dinner on May 15th. For the meeting on the 17th, 110 delegates from both sides attended the conference. Chairman Kuo, Lin-Wu of CIECA's Mongolia Committee (Vice Chairman, Taiwan External Trade Development Council, TAITRA) and Mrs. Magvan Oyunchimeg jointly presided over the conference. Experts and businessmen from both sides reported on business opportunities and exchanged views on "Mining", "Renewable Energy", "Investment Environment in Mongolia",

"E-Commerce" and "Experience Sharing". During their stay, Mongolian delegates have been arranged to visit the Export-Import Bank of the Republic of China which is responsible for financial business between the two nations, TAITRA, ANKO Food Machine Co., Ltd. and King Car Group's Kavalan Distillery with the expectation of exploring substantive business opportunities.

Pre-departure briefing for "2017 Investment and Trade Mission to Swaziland, Mozambique, and South Africa"

In addition to confirming the mission's itinerary with the delegates and reminding them of safety and weather considerations, the briefing saw the three ambassador and representatives gave precious counsel. "Southern and eastern African countries devote themselves to regional cooperation such as SACU. **SADC** projects and COMESA to enlarge the market increase global competitiveness," said HE Mr. Dlamini, who spoke not only on Swaziland's behalf, but also for neighboring nations. His Excellency also suggested that the mission pay a short visit to the Royal Science and Technology Park in Matsapha, Swaziland on June 19. The park, whose excellent infrastructure is supported by the Taiwanese government, is located at the regional import/export hub and in need of foreign direct investment. South African Rep. Aphane suggested that the hotel used on June 22 be changed, and that he arrange a meeting on June 26 between the delegates and Wesgro, the tourism, trade investment promotion agency for Province of Western Cape. Finally, Rep. Yeh of Mozambique added that he will show the delegates a Portuguese glass factory 40 minutes from Maputo, the capital. The factory was shut down due to mismanagement several years ago, but is well situated with abundant water and electricity supply, and should be able to get up and running with minimal investment.
