2017 Investment Delegation to allies in the Caribbean

In order to strengthen cooperation with the Caribbean region, the Chinese International Economic Cooperation Association (CIECA) organized the "2017 Investment Delegation to allies in the Caribbean", with the objective of conducting a survey of the development of industry and economy of four countries, Saint Vincent and the Grenadines, Saint Lucia, Federation of Saint Kitts and Nevis and Dominican Republic for total 13 days, from August 5 to 17.

For the purpose of understanding local investment and trade opportunities and with promote opportunities local manufacturers so as to explore bilateral potential technology and industry cooperation, the Ambassador on Home Assignment of Foreign Affairs of the Republic of China (Taiwan), George T.K. Li personally headed this "Investment Delegation" and held symposia with the local governments and relevant departments during the visit. 
