The 24th Joint Meeting of Chinese-Philippine & Philippine-Chinese

Business Councils was successfully held in Manila on December 7, 2017

In conjunction with the 23rd Ministerial Joint Economic Cooperation Meeting and the government's promotion of its New Southbound Policy, CIECA organized a Taiwanese delegation led by Mr. Clement Yang, Chairman of the Chinese-Philippine Business Council, CIECA to visit the Philippines on December 6-9, 2017. The 24th Joint Meeting of Chinese-Philippine & Philippine-Chinese Business Councils was held on December 7, 2017 at the Dusit Thani Hotel. In the morning, there was business matching and networking. In the afternoon, the meeting was co-chaired by Mr. Clement Yang and Dra. Luzviminda Jose (Incoming Chairperson, Philippine -Business Council), Chinese President. 


