32nd Joint Conference of ROC-Australia and Australia-Taiwan Business Councils

32nd The Joint Conference of the **ROC-Australia** and Australia-Taiwan Business Councils was held on August 31st at the Far Eastern Plaza Hotel. Chairman John Toigo of the Australia-Taiwan Business Council led 56 Australian from the fields delegates of energy, food. logistics, education. finance. professional baseball and other civilian business leaders including Mr. Graham Fletcher, First Assistant Secretary of the North Asia Division, Dept. of Foreign Affairs & Trade; Rep. Gary Cowan, Australian Office Taipei and other federal and state officials; Mr. Peter Chan, CEO, ANZ Bank (Taiwan) Ltd.; Mr. Ryan Chua, Taiwan Country Head, Macquarie Capital other businessmen to attend the Chairman Yang, conference. Wei-Fuu. ROC-Australia Business Council (Chairman of Taiwan Power Company) and Chairman Toigo jointly presided over the conference. More than 200 people from both sides

registered to attend.

The honored guests of the conference included Ms. Wang, Mei-Hua, Vice Minister of Economic Affairs and, First Assistant Secretary Graham Fletcher who delivered remarks during the opening ceremony. The conference also held a forum on "Australia-Taiwan Trade and Investment: Business around Building the New Southbound Policy". Dr. Michael Hsiao, Taiwan-Asia Chairman. Exchange Foundation. civilian. professional organization to assist our government in the promotion of the New Southbound Policy and implement comprehensive exchanges and cooperation in Asia and Mr. Ross Maddock. OAM. Chairman Emeritus. Australia-Taiwan Business Council jointly presided over the forum and led scholars, businessman and official from a supervising agency to discuss, analyze and provide suggestions for the consideration of the two governments.

Conference topics include "Energy", "Finance" and "Digital Economy" with 9 speakers from both nations delivering

professional reports. This year's conference also arranged to discuss "Case Studies of Business Cooperation between Taiwan and Australia". Joint investors from both sides including Swancor Renewable Energy Co., Ltd. and WeatherRisk Explore Inc. shared their experience in cooperation and its results. Such successful cases can lead to opportunities for diverse cooperation. CIECA also arranged for senior members of the Australian delegation to visit Taiwan Electrical and Electronic Manufacturers' Institute Association. for Information and **Industrial** Technology Industry Research Institute to discuss the direction of future cooperation. A new member of ATBC, Mr. Cameron Vale, CEO, Baseball Australia, also used this opportunity to visit Taiwan and visited professional baseball-related organizations in search for opportunities of mutual cooperation.

CIECA Organized the Industrial Visit for Its Board of Supervisors, Board of Directors and National Committees on August 10, 2018

In order to better understand the industrial policy in Taiwan, CIECA organized an industrial visit for its board of supervisors, board of directors and national committees on August 10, 2018. The delegation included 30 people led by Mr. Fred P.C. Huang and Mr. Jeff Sun, vice chairmen of CIECA, to visit Delta Taoyuan Plant 3, Namchow Recreational Factory and Tatung Company.

In the morning, the delegation arrived of Gold-rated Delta's certification building factory in Taoyuan Plant 3 and R&D Center. The Plant 3 and R&D Center fulfills the Delta Group's Founder Mr. Bruce Cheng's mission: "To provide innovative. clean and energy-efficient solutions for a better tomorrow." It also employs Delta's own energy saving and industrial automation products and control systems. Eco-friendly features of plant 3 include solar panels, HVAC (Heating,

Ventilation, and Air Conditioning), LED lighting, water resource processing and renewable energy equipment that not only trims the annual power bill by NT\$5 million, but also reduces 1,000 tons of CO2 emissions and uses about 75% less water.

Namchow Recreational Factory demonstrated its various business achievements. The Namchow Group started its business in crystal soap production and its product lines have been extending from soap products to chemical industry, oils and fats, frozen dough, food, and catering service between Taiwan and China. Its most well known five-star restaurant is Dian Shui Lou which is famous for its Chinese cuisine.

In the afternoon, the delegation traveled to Fudekeng Environmental Restoration Park to observe the landfill solar power plant named "Taipei Energy Hill," a result of cooperation between Taipei City Government and Tatung Company. The demonstration renewable energy park environmental education, integrates eco-environment and green energy. The solar power plant consists of approximately 8,000 solar panels. The facility is expected to generate 2 million kilowatt-hours of electrical energy and reduce yearly carbon dioxide emissions by 1,108 tonnes, which is

2.8 times the amount that Daan Forest Park can absorb in a year. It is also capable of generating 2 million kilowatt-hours of electricity per year, equivalent to supplying 570 households with electricity.

Other than the stable development of Green Energy Business, Tatung Company also develops Smart Living Management System. Senior Vice President Lin, Hur-Lon, not only briefed on helping poor areas in Southeast Asia to improve their quality of life but also delivered a presentation on the functions and applications of Smart Living. In addition, the delegation also visited a Smart Home.

The delegates greatly benefited from the industrial visit organized **CIECA** by including the current mainstream ideas of Building, Smart Living, Green Green Energy and other issues. **CIECA** successfully played the role of promoting industrial exchanges.
